Inconvenient Truth

The film "Inconvenient Truth" is a mustsee for everyone, no matter what position you take on global warming and no matter your political persuasion.

When you see this film, our global predicament comes clear. Mr. Gore understands the science and makes great use of visuals to teach all of us the basics. He explains how the American media has been blindsided on the issue. And he offers hope for effective responses to help reduce the impacts of global warming.

The film ends with a litany of actions to take to combat global warming. At the top of the list is: use and expand public transit, since gasoline-powered vehicles are a prime culprit in CO2 emissions.

Higher gasoline prices have already stimulated increased use of public transit in WNY. Recent figures for NFTA transit ridership shows increase of 4.8% for Metro Rail and 1.6% for Metro Bus during 2005-2006.

The globe is already experiencing some of the impacts of global warming. Weather events are more severe and drought is unrelenting. Melting polar ice will cause sea levels to rise, inundating coastal cities. Migration to escape such situations is inevitable.

Buffalo has great assets during this time of global warming: a ready infrastructure to accept more people and the start of a comprehensive light rail transit system.

Let's build on our assets and welcome people who are tired of hurricanes and drought, flooded homes and ruined crops.

Let's insist that Buffalo act now, to grapple with this "inconvenient truth!"

Bruno: Light rail in Capital region's future

ALBANY -- State Senate Majority Leader Joseph Bruno, R-Brunswick, said Monday he expects light rail to play a role in the Capital Region's transportation future.

"Light rail ... is the most economical and efficient way in moving people," he said during a conference call with reporters [June 26].

Bruno said a study has been commissioned that will look at potential routes, although he said the logical connections would be between the Rensselaer train station, Albany International Airport and the area's cities, including a route north to Saratoga Springs.

Ed. note: Any progress in Albany will be good for our efforts in Rochester and Buffalo.
