Of course we have to fix the dangerous bridges and roads -

One quarter of the nation's bridges, including the one that collapsed in Minneapolis, have been classified structurally deficient or functionally obsolete. One third of our major roads are judged by federal transportation officials to be in poor or mediocre condition.

According to the GBNRTC, their new Master Plan envisions spending \$6.1 billion on improvements and upgrades in this area through 2030.

I do hope "improvements" doesn't mean widening and expanding highways. If it does, a fair share of those dollars should be used instead for Metro Rail expansion..

One member of congress wants to increase the Federal gas tax by a penny for roads and bridges. I say, increase it by two cents and use the other penny to support intra-city mass transit and intercity high speed rail.

We cannot continue to be addicted to automobiles. And, buses aren't the answer. Light rail rapid transit is. Car owners won't leave their cars in the garage to ride a bus, but they will use park-and-ride facilities to use rail transit.

# "Metro Rail Helps Raise Property Values" a presentation by Daniel B. Hess, Ph.D.

Dr. Hess will discuss his recent study: "Metro Rail Helps Raise Property Values: A Quantitative Exploration of House Values and Proximity to LRRT Stations in Buffalo, New York."

Daniel Baldwin Hess is Assistant Professor in the Department of Urban and Regional Planning at the University at Buffalo. His research centers on public transit operations and finance and the interaction between travel behavior and urban form. He won the 2004 Chester Rapkin Prize from the Association of Collegiate Schools of Planning and the 2005 University at Buffalo Exceptional Scholar Award. He recently received an Emerging Scholar Grant from University Transportation Research Center to investigate walking access to bus stops for older adults over age 60.

#### State To Fund \$22M For Higher-Speed Rail Program

...NYSDOT 9-5-07

New York State Department of Transportation (NYSDOT) Commissioner Astrid Glynn today [9-5-07] announced a \$22 million program as a first step in bringing reliable, higher-speed rail service to New Yorkers throughout the state.

The funding would provide \$4 million for rock slope stabilization near the George Washington Bridge. Other initial investments under the program are expected to extend the existing platforms and canopies and construct a fourth track and related signal work at the Albany-Rensselaer Station and reconfigure the Hudson Station.

"The state is committed to building a modern, efficient higher-speed rail system," Governor Spitzer said. "A higher-speed, more efficient rail system is a critical component to connecting our communities for tourism and economic development purposes."

"Reliable, higher-speed rail is an important component of a multi-modal transportation network geared to meeting the mobility needs of New Yorkers and the demands of a growing economy in the 21st century," Glynn said. "The state Department of Transportation welcomes the challenge of leading this endeavor. Together, we have already made more progress in one month than in all of the past year."

In addition, today an initial meeting was taking place on a critical study into issues of "unity of control." That analysis will seek to optimize both freight and passenger service by the four rail operators -- CSX, Canadian Pacific, Metro-North and Amtrak – in the important New York-to-Albany corridor.

The higher-speed rail plans also would establish a working group, led by NYSDOT and comprised of the Capital District Transportation Committee, the Senate High-Speed Rail Task Force and the four railroad operators, to advise the NYSDOT in developing a higher-speed system that provides a clear public benefit through improved on-time performance, increased frequency of service and reduced travel time.

#### Blue Bikes at UB

The University at Buffalo has developed a new program 'Bicycling at UB' to encourage greater bicycle use by the university community. New bike racks have been installed on the front of the UB buses allowing riders to carry their bikes between and within campuses and additional racks have been placed across campus. A free registration is required for all campus bikes. In partnership with Buffalo Blue Bicycles, individuals can borrow bikes from various sites on campus. The Buffalo Blue Bicycles program has installed hubs on all UB campuses (3-North Campus; 3-South Campus; 1-Buffalo Niagara Medical Campus).

# Public Transit ridership, NFTA, 1st Quarter, 2007

First quarter ridership figures for 2007 show 94,000 weekday riders carried by NFTA buses, light rail and on-demand services. Of that total, 21,200 riders were using Metro Rail's 6.2 mile route and 72,400 riders were using Metro Bus's 1,305 directional miles of road.

Put another way, Metro Rail's single line carries 30% of the total transit ridership on a weekday, or 1,709 riders per mile of rail.

Metro Bus's many routes carry 55 riders per mile of road.
