Crowd Says "No!" to Cars on Main Street

On August 29th, more than 35 people crowded into the 14th floor City Hall conference room to hear details about Buffalo's Cars on Main Street project.

The group heard first from the engineers and architects, who justified removal of the Theater Station as a safety measure in order to allow cars to merge onto the Metro Rail trackbed.

Next, Citizens for Regional Transit made a brief presentation, showing their alternate design, which keeps the Theater Station while providing space for cars to travel parallel to the Metro Rail trackbed.

Thirteen citizens then spoke, united against the removal of the Theater Station and having motor vehicles share the trackbed.

They demanded: Who is looking out for the disabled and elderly? Why haven't we heard about this project before now? Who benefits? What about the people who rely on the Theater Station? Will you take a look at the alternative design?

Stephen Stepniak, Buffalo's Public Works Commissioner, responded that he will look carefully at the CRT alternative design. CRT invited him to their meeting, Sept. 21.

Many of the citizens at the meeting were members of VOICE-Buffalo, Citizens for Regional Transit, and the League of Women Voters Buffalo-Niagara.

Transportation, Amtrak Funding Yanked Around by Congress

Deal funds highways, airways

Congressional leaders struck a deal late Friday [9-9-11] to extend temporarily the expiring laws governing the nation's highways and airways at roughly their current funding levels.

The bill would authorize programs of the Federal Aviation Administration through January and surface transportation laws through March. Highway programs would be funded at the fiscal 2011 rate — \$41.7 billion — far above the \$27 billion approved in their budget earlier this year. Because the extension is for six months and not a full year, the actual amount authorized is half of the fiscal 2011 level. The FAA would get about \$5.4 billion for the four-month period beginning in October and ending Jan. 31.

Without action, authorization for both highway and aviation programs would expire at the end of this month, and both President Barack Obama and members of Congress have warned that scenario could cost hundreds of thousands of jobs.

"Rails-to-Trails Conservancy (RTC) confirmed with Senator Tom Coburn's (Okla.) office that he plans to **introduce an amendment to eliminate the dedicated set-aside for the Transportation Enhancements (TE) program** from the extension. He may even go so far as to filibuster to get his way, blocking the whole bill, including maintenance and construction of roads, bridges and transit. **TE is the nation's largest funding source for trails, walking and bicycling**."


The House Appropriations Subcommittee on Transportation & Housing proposed slashing funding for Amtrak to \$1.1 billion—a reduction of more than \$357 million from what Amtrak received in FY2011. Significantly, the operating grant would be cut 60%--from \$563 million in 2010 and 2011, down to \$227 million. The bill requires states to pay 100% of costs of operations of short corridors. This apparently overrides ongoing negotiations among states and Amtrak aimed at complying with Amtrak's 2008 reauthorization law. Aging in Place, Stuck Without Options

Aging in Place, Stuck without Options: Fixing the Mobility Crisis Threatening the Baby Boom Generation, issued by Transportation for America, reports on an emergent transportation crisis for seniors.



In 2000, an estimated 11.5 millions persons 65 and older had inadequate transportation options, with a projected 35% increase to 15.5 million by 2015.

The Buffalo-Niagara Falls, NY Metropolitan Area is projected to have 87,954 seniors without adequate access to transportation in 2015, or 49% of the local senior population.

The post-World War II baby boomers are now becoming senior citizens. They are living longer than previous generations, resulting in more years of declining health and limited driving. They will be living on fixed incomes, resulting in less financial ability to own a car.

More federal funding is recommended for programs that go beyond bus and train to include smaller vehicles (vans, ridesharing) for short-route shuttles to take seniors to shopping and health care. A coordinated multimodal system is ideal. Communities are encouraged to include seniors in the planning of such programs. A "complete streets" policy" should accommodate seniors walking between home and bus stops/train stations.

There is an especially acute need in rural and suburban areas, where a majority of seniors reside. Ironically, the NFTA has recently cut back on bus services in outer areas. Fortunately, there is federal funding that has been earmarked specifically for the elderly and for rural areas.
